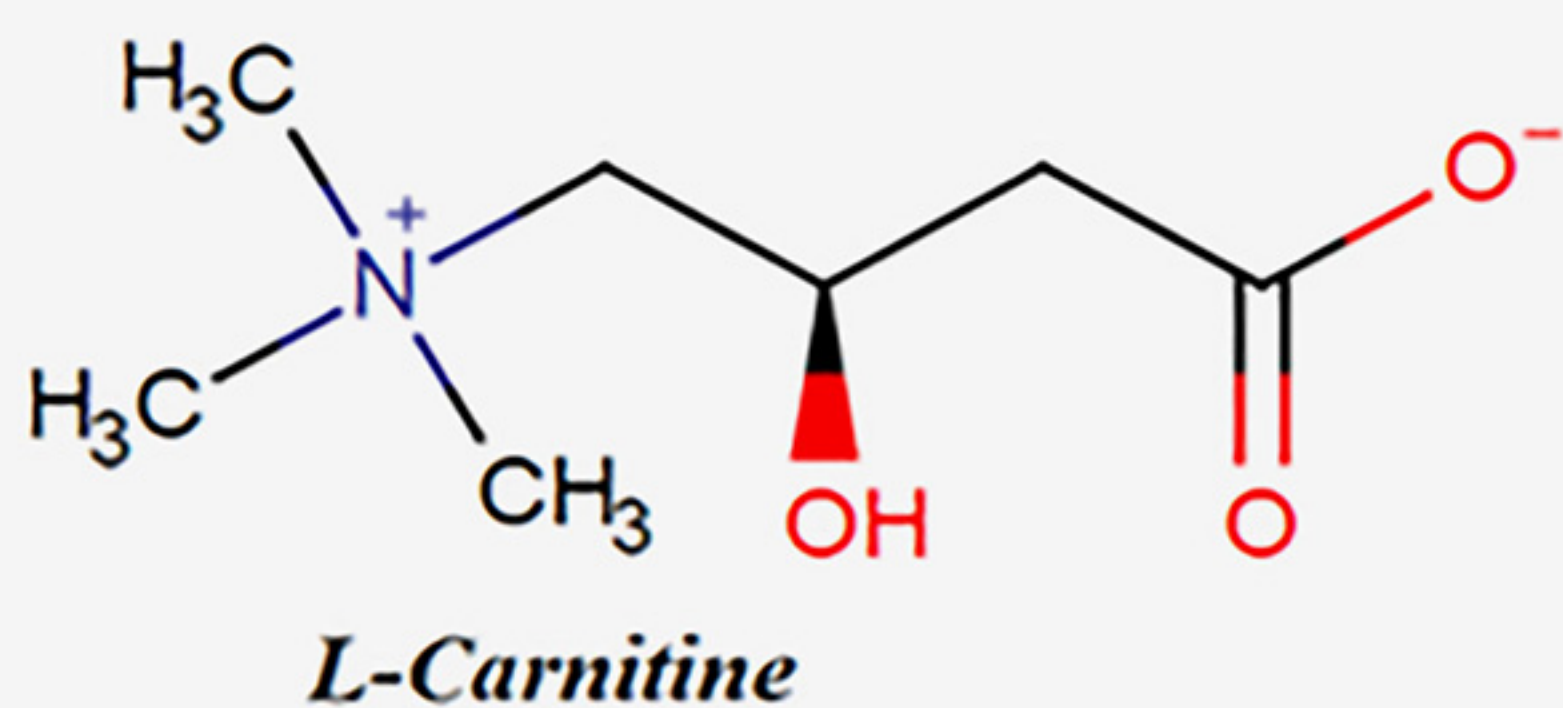
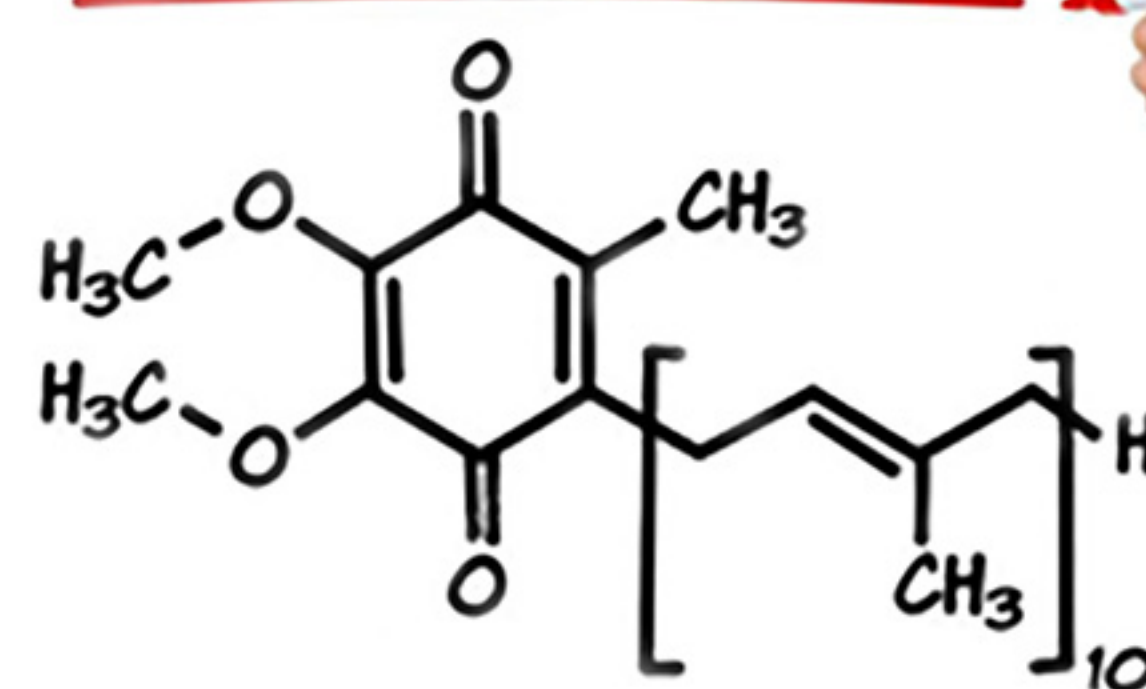
### Coenzyme Q10\*
